The first is a Memorandum of Understanding with Air New Zealand, which is initially with NMIT, but opens broad discussion about engagement across Te Pūkenga network. The second is an agreement to establish the New Zealand-China Vocational Cooperation and Development Alliance, which has been achieved through working with Education NZ following the Chief Executive's visit to China in June. This will involve working with institutions across China to engage with the national network of Te Pūkenga.

The Chief Executive also indicated that the conclusion of the consultation on organisational change will be within the next two weeks. He acknowledged the rich and insightful feedback from kaimahi and highlighted that over 8,000 pieces of feedback had been received.

Kōrero Whakapōpoto | Executive Summary

On 20 September, we confirmed our new operating structure to all kaimahi for delivering better outcomes for ākonga and employers through a single unified organisation. The new structure provides a once-in-a-generation opportunity to redesign vocational education to help more ākonga learn and train in a way that suits them, and with the support they need for success. It also aims to provide the skills that our employers and economy need now and in the future.

The new structure will result in 200 fewer full-time equivalent roles across the network, with the expectation that the majority of affected kaimahi will be redeployed. The final structure has 602 new roles, with 401 being disestablished. Another 51 positions that are currently vacant are also being disestablished, and 350 fixed term employment agreements will not be extended beyond their current term. Recruiting for the new positions has begun.

The new structure has largely been well received, with kaimahi particularly pleased to see that their considerable feedback had been heard and incorporated.

While enrolments continue to be down at Te Pūkenga and across the tertiary education sector, we continue to see growth in international education, and expect this to continue as we rebuild post lockdowns.

Te Pūkenga celebrated new buildings being opened, welcoming a teaching excellence consortium, and success at the Te Whatu Kairangi - Aotearoa Tertiary Educator Awards.



Ngā mahi matua i te wā o te pūrongo | Key activity during reporting period

Following consideration of more than 8,000 pieces of feedback from kaimahi and further design work, the leadership team announced the decisions of Tāraia te anamata | Creating our futures consultation for five business groups.

More than 3,000 kaimahi attended the announcement live online, with hundreds more gathered at sites throughout the country to watch it together. In addition to staff and union briefings, we also updated a wide range of stakeholders about our decisions, including the Minister of Education, ākonga, employers, Te Pūkenga Council advisory committees, Regional Skills Leadership Groups, Workforce Development Councils, international partners, education agencies and others.

Kaimahi whose roles have been disestablished were informed individually ahead of the all-staff hui and have been encouraged to apply for the new positions as we want to retain as much of our talent and expertise as we can and avoid redundancies wherever possible.

Different groups will transition at different stages to the new structure. This will be phased over the next few months, to minimise disruption of delivery to ākonga, employers, industry, and other partners. Further details on the transition for the change process is in my report for the closed session.

On 13 September 2023, the Prime Minister Rt. Hon. Chris Hipkins attended the formal opening of He Toki Kai Te Rika, a multi-million-dollar trades training centre at Otago Polytechnic | Te Pūkenga. He Toki Kai Te Rika translates as "a tool for your hand" and was gifted to Otago Polytechnic by local rūnaka. The \$31.7 million facility is located at the heart of the Forth Street Campus in Dunedin. The building will support both work-based and on-campus ākonga including those studying the Bachelor of Engineering Technology (with Civil, Mechanical, and Electrical Engineering specialities), New Zealand Certificate in Engineering (Level 3), Welding (night classes), New Zealand Diploma in Construction, Bachelor of Construction (Quantity Surveying). It will also support work-based apprentices and block courses.

Other Ministerial involvement in events on Te Pūkenga sites included:

- The Tertiary Education Union hosted a political panel at Unitec | Te Pūkenga during their stop-work meeting on 14 September 2023. Hon Jan Tinetti addressed the session online in her capacity as Minister of Education. The political panellists comprised of Chris Baillie (ACT Party), Helen White (Labour Party), Hon Paul Goldsmith (National Party), and Julianne Genter (Green Party).
- Hon. Willow-Jean Prime, Minister of Conservation and Youth, and Member of Parliament (MP) for Northland, attended the graduation for the Diploma in Whanau Ora (Level 5) at the Ngawha campus of NorthTec | Te Pūkenga on 15 September 2023.
- Hon Grant Robertson, Minister of Finance, Sport and Recreation, Cyclone Recovery and Leader of the House, visited Nelson Marlborough Institute of Technology | Te Pūkenga campus in Blenheim on 25 September 2023.

Opposition Leader Christopher Luxon visited the Telford | Te Pūkenga campus near Balclutha and together with National MPs Erica Stanford and Penny Simmonds announced the National Party



international education policy at Te Rau o te Huia, the new creative technologies building at the Southern Institute of Technology (SIT) | Te Pūkenga campus in Invercargill on 21 September 2023.

We had three award winners in Te Whatu Kairangi – Aotearoa Tertiary Educator Awards for 2023. They are:

- Craig Goodhue Unitec | Te Pūkenga General Category Winner: Advancing Approaches to, and the outcomes of, work-based learning
- Genevieve Togiaso Ara Institute of Canterbury | Te Pūkenga Le Moana Mua Award
- Group led by Dr Grant Bennett with Heather Compton, Alan Hoskin, Tracy Hutton, Derek Chirnside, Elaine Rutherford, Clare Hutchinson, and Marion Hale - Ara Institute of Canterbury | Te Pūkenga - General Group Category Winner: Progressing Education Partnerships and Collaboration

The awards recognise sustained excellence in tertiary teaching and the difference this makes for ākonga, their whānau and communities. Ako Aotearoa, an organisation committed to supporting tertiary educators to enhance success for all the country's learners, has been running the awards on behalf of the Minister of Education since 2007.

We welcomed the National Centre for Tertiary Teaching Excellence (NCTTE) to Ngā Kete Wānanga marae at Manukau Institute of Technology | Te Pūkenga campus in Ōtara on 15 September 2023. Earlier in the year, it was announced that Te Kunenga ki Pūrehuroa, a Massey University-led consortium with Te Wānanga o Aotearoa and Te Pūkenga had successfully bid to host the NCTTE for the next three years. The consortium will reposition Ako Aotearoa in a changed tertiary education and training context in Aotearoa New Zealand. The NCTTE fund provided \$3.556 million per annum to deliver a centre that works in partnership with tertiary education organisations (TEOs) to build teaching capability of TEOs and educators; commission and conduct research, monitor and evaluate effective teaching; and administer the tertiary teaching awards.

The Otago Regional Service Delivery Trial was recently completed following a 16-month trial involving Otago Polytechnic, SIT and BCITO | Te Pūkenga. The trial was established as an opportunity for the three formerly competing providers to explore ideas, test initiatives and implement ways to unify the delivery of their respective Level 4 carpentry programmes to support better outcomes for the approximately 100 carpentry apprentices across the Otago and Southland regions. The trial began in March 2022 and ended in June 2023. It was funded by the Tertiary Education Commission under its Strategic Component Funding for vocational education.

During this reporting period, Te Pūkenga has held graduation ceremonies for graduates from Manukau Institute of Technology, NorthTec and Otago Polytechnic | Te Pūkenga. One graduand shared that she had decided to retrain in horticulture following a serious head injury. The former hairdresser credits the ability to undertake her studies through distance learning for being able to complete the programme over two years.

Also during the past month:

 BCITO | Te Pūkenga and Education Unlimited, a workplace training provider, joined forces to run an apprentice support programme for 15 Te Tai Tokerau apprentices. The Critical Skills Apprenticeship Programme has been designed to boost apprenticeship success and help aspiring tradies navigate the formal aspects of their mahi. The five-month programme

included five workshops and additional one-on-one sessions for each apprentice. BCITO hopes to roll the programme out nationwide following the pilot.

- Careerforce | Te Pūkenga recently celebrated its 1,200th apprentice training in the
 Apprenticeship in Mental Health and Additional Support programme. These mental health
 apprenticeships were developed in 2017 following the increasing demand in mental health.
- Connexis | Te Pūkenga held their annual Excellence Awards celebrating trainees in the
 Electricity Supply and Telecommunications industries on 21 September in Invercargill. Abbey
 Meiritz Reid was named Trainee of the Year and Distribution Trainee of the Year. She is a
 trainee electrical fitter with Connectics in Christchurch.
- Horticulture ākonga at EIT | Te Pūkenga have had hands-on industry experience helping
 restore an orchard devastated by Cyclone Gabrielle. Three groups of ākonga completed a
 three-day Fruit Supports Structure course as part of the NZ Certificate in Primary Industry
 Operational Skills. This provided a great way for ākonga to apply skills and theory they have
 learned in the field.
- Open Polytechnic | Te Pūkenga is providing greater access to courses for ākonga and
 increased flexibility to study at their own pace, by recently changing to a monthly enrolment
 intake for most of its business degree offerings in the Bachelor of Business, Bachelor of
 Applied Management, and graduate qualifications in business. The new monthly enrolment
 intakes offer a more learner-centric approach, placing the needs and preferences of ākonga
 at the centre as well as being able to provide more flexibility for employers with qualified
 graduates being available throughout the year.
- Primary ITO | Te Pūkenga is helping to address a skills shortage in the pork industry with its
 New Zealand Certificate in Pork Production Level 3. This programme has helped three
 ākonga in particular to grow and progress in their jobs with their employer, Waratah Farm in
 South Waikato. One of the ākonga, who is a farm hand, is set to continue her career in the
 pork industry after having the opportunity to gain the qualification while working on the
 job.
- SIT | Te Pūkenga has added a Master of Nursing Science degree to its roster of courses after an increased demand for nurses across the country.
- UCOL | Te Pūkenga celebrated a significant increase in course completion rates of ākonga Māori. In 2019, there was an 18 percent gap in completion rates between ākonga Māori and non-Māori which had reduced to a very narrow 0.66 percent last year. UCOL put this down to its focus on providing a more welcoming, inclusive, and culturally aware learning environment, strong leadership, skilled kaimahi, and a relationship-based teaching practice called Te Atakura.
- A new gallery supporting ākonga, kaimahi and Aotearoa art and design community has
 opened at Unitec | Te Pūkenga. Toi o Wairaka has been unveiled as part of the School of
 Creative Industries' new facilities in the Mt Albert, Auckland campus. The opening
 reaffirmed the business division's heritage in the arts, celebrate the depth of talent of our
 ākonga and kaimahi as well as showcase the new School of Creative Industries facilities.
